

## **“Fuel Your Dreams” Promotion – Terms and Conditions**

Welcome to the 2025 “Fuel Your Dreams” Promotion. Below are the official **Terms and Conditions (hereinafter “Rules”)** which govern the Promotion of the 2025 “Fuel Your Dreams” Promotion (hereinafter referred to as the “Promotion”), operated by Sol Jamaica SRL (“Texaco Licensee”) through its licensed brand Texaco. The Rules may also be referred to as the “Competition Rules” in related publications relating to the Promotion. Any individual who meets the eligibility criteria below may submit a valid entry in accordance with these Terms and Conditions (hereinafter “Participant”).

### **1. DURATION OF PROMOTION**

Eligibility for entry in the Promotion shall be for a period of eight (8) weeks starting on July 28<sup>th</sup>, 2025, to September 20<sup>th</sup>, 2025, at 11:59pm.

### **2. ELIGIBILITY**

The Promotion is open only to persons who are legal residents of Jamaica and who are 18 years of age or older at the time of entry. The Promotion is not open to employees (full, part-time, temporary, etc) of Sol Jamaica SRL and their parent company, affiliates and subsidiaries; their advertising, public relations, direct marketing and Promotion agencies; retailers, managers and staff (full, part-time, temporary, etc) of Texaco service stations or immediate family members of such employees; and/or any entity or the owners of such entities related to the development, Promotion or approval of the Promotion, their employees and immediate family members of such employees and owners. By entering the Promotion, the participant agrees to abide by these Terms and Conditions. For the purpose of these Terms and Conditions the term “immediate family member” means spouse, child, brother, sister, uncle, aunt, first cousin and second cousin.

### **3. RULES OF THE PROMOTION/PROMOTION MECHANICS**

- The Promotion is limited to the geographic area of Jamaica and its legal residents and is subject to all applicable laws and regulations. These Terms and Conditions and the Promotion shall be governed by the laws of Jamaica.
- The Promotion is limited only to fuel purchases (gasoline or diesel) from one of the fifty-nine (59) participating Texaco Service Stations (Please see the attached Appendix A).
- For each purchase of Three Thousand Jamaican Dollars (J\$3,000.00) or more in fuel (gasoline or diesel) inclusive of all taxes and charges, the purchaser will receive one (1) entry coupon.

- For each purchase of Six Thousand Jamaican Dollars (J\$6,000.00) or more in fuel (gasoline or diesel) inclusive of all taxes and charges the purchaser will receive two (2) entry coupons,
- For each purchase of Nine Thousand Jamaican Dollars (J\$9,000.00) or more in fuel (gasoline or diesel) inclusive of all taxes and charges the purchaser will receive three (3) entry coupons.
- Entrants with a qualifying purchase must:
  - (i) fully complete the entry coupon with their full name and telephone number.
  - (ii) drop the entry coupon into the box provided at the participating Texaco service station for a chance to win a Promotion prize. The drop box will be clearly identified.

Method of Selection of Winner(s) - All entries from all 59 sites will be combined into a spin drum for the draw. There will be one (1) draw conducted to determine the winners of the prizes: September 26<sup>th</sup>, 2025. Two back-up winners will be selected for each prize in the event the winners are unreachable within 3 days following the drawing. Additional draws will be conducted until all prizes are awarded. The order of the drawings will be as follows:

1. The first valid entry selected will receive a cash prize of One Million Five Hundred Million Dollars (J\$1,500,000.00)
2. The next valid entry selected will receive second place cash prize of One Million Jamaican Dollars (J\$1,000,000.00)
3. The next valid entry selected will receive the third-place cash prize of Five Hundred Thousand Jamaican Dollars (J\$500,000.00)

The cash prize will be given to the winner in the form of a Manager's Cheque. Winner will collect the Manager's cheques at Sol Jamaica SRL's (Sol) head office located at the R. Danny Williams Building, 8<sup>th</sup> Floor, 28-48 Barbados Avenue, Kingston 5

- All valid entry coupons will be clearly stamped with a Sol Jamaica SRL stamp.
- Draw date, time and venue: September 26<sup>th</sup>, 2025, at Sol Jamaica SRL, 28-48 Barbados Avenue, 8<sup>th</sup> Floor, Kingston 5 between 11:00 a.m. and 1:00 p.m.
- Sol reserves the right to publish the winner's name without first contacting the winners. Participants also agree with Sol's use of their name, relevant information, and voice and image via photograph or video recording, for promotional activities without any additional compensation.

#### **4. METHOD OF NOTIFICATION**

Winners will be notified by telephone or by email within two (2) business days after the drawing. At least 3 attempts per day will be made over a 3-day period to contact the winners. If we are unable to contact the winners, attempts will be made to contact the first person from the backup list. This process will be repeated if necessary. Sol may at its discretion, conduct additional draws on or about the 27<sup>th</sup> of October 2025 in accordance with the Promotion Mechanism detailed at Point 3, in the event that there is any unclaimed prize, until all prizes are awarded.

These Terms and Conditions will be published on the week of August 4 to August 8, 2025, in the Gleaner and the Observer, and will also be available at participating Texaco service stations through poster on the store front or from the offices of Sol, located at R. Danny Williams Building, 8<sup>th</sup> Floor, 28-48 Barbados Avenue, Kingston 5, Jamaica.

#### **5. COMPETITION PRIZES**

The prizes will consist of the following:

- Prizes
  - 1st – One (1) Cash prize of One Million Five Hundred Thousand Dollars (J\$1,500,000.00)
  - 2nd – One (1) Cash prize of One Million Dollars (J\$1,000,000.00)
  - 3rd – One (1) Cash prize of Five Hundred Thousand Dollars (J\$500,000.00)

All taxes as well as any incidental or other expenses associated with the prizes herein to be awarded, together with all government reporting, payment and any other requirements are the sole responsibility of the winner. The actual odds of winning the prizes will be dependent upon the number of eligible entries received and Sol makes no guarantees about each participant's chances of winning.

#### **6. REDEMPTION OF PRIZES**

All prizes must be collected at the pick-up location communicated to the winner within the time communicated to the winner not exceeding 30 days after contact is made. A valid photo identification such as a driver's license, passport or national voter's identification card must be presented. Failure by any winner to claim their prize in accordance with these Terms and Conditions will result in the forfeiture of the prize and Sol shall be free to award the prize to another winner without liability to that winner. Prizes are not transferable.

## **7. PROMOTION CONDITIONS – DATA PROTECTION**

Participants can enter as many times as they wish. However, they are only allowed to win once.

All data collected through the entry coupons will be treated as confidential and used solely for the purpose of communicating with winners. Once submitted, entry information cannot be modified. In accordance with the Data Protection Act of Jamaica, each entry coupon will include a consent statement authorizing the use of the Participant's information for the purpose of the Promotion. The Participants' information may be used thereafter for direct marketing purposes, subject to the Participant's right to opt out at any time.. Sol Jamaica SRL will not share Participants' personal data with third parties, except as required by law or for the fulfillment of Promotion-related obligations.

Sol's decision with respect to any incomplete transmission will be final subject to the approval of the Betting, Gaming and Lotteries Commission.
