

“Sleigh The Season” - Mobil Guyana Promotion

TERMS & CONDITIONS

The following are the **Terms and Conditions** of the “Sleigh the Season” Promotion (hereinafter referred to as the “promotion”), operated by Sol Guyana Inc.

- a) How to Enter: Fuel up with \$5,000 GYD or more on fuel, write your full name, telephone number(s), and email address on the entry coupon provided, and drop it in the boxes provided at any participating Mobil Service Station, for a chance to win.
- b) Eligibility: To participate in this promotion, entrants: (i) must be at least eighteen (18) years of age and (ii) must be a resident of Guyana.
- c) This promotion is valid only at participating Mobil-Branded Service Stations in Guyana.

2. Promotion Period: **December 3rd – January 9th, 2026.**

3. **Prizes:** Participants will have a chance to win the Grand Prize and/or Consolation Prizes. Coupons must be submitted by January 09, 2026 at 11:59 pm to be included in the grand prize draw on January 12th, 2026. The participants must follow the rules to have a chance to win.
